## Maps to Fields

St. Cloud: Waite Park, 76ers, Chutes (Faber and Putz)



### From I-94 East (Mnpls - St. Paul)

Take I-94 to the Highway 15 exit -- Take Highway 15 north into St. Cloud -- Proceed to 8th Street North (Veterans Drive) -- Turn LEFT (West) onto 8th Street North (Veterans Drive) -- Proceed appx. 3/4 mile -- The MAC will be on the right in front of a light blue St. Cloud Water Tower.

### From Highway 10 South (Elk River - Coon Rapids)

Take Highway 10 to the Highway 23 exit -- Take the Highway 23 West bound exit -- Proceed to Highway 15 -- Turn RIGHT (North) onto Highway 15 -- Proceed to 8th Street North (Veterans Drive) -- Turn LEFT (West) onto 8th Street North (Veterans Drive) -- Proceed appx. 3/4 mile -- The MAC will be on the right in front of a light blue St. Cloud Water Tower.

## Maps to Fields

### Sauk Rapids:

Take Highway 10 through St. Cloud. After you go through a set of stoplights (Subway, McDonald's, Wendy's), take the BENTON DRIVE exit to your right. When you get to a stop sign, take a left. You'll go through 2 stoplights. When you get to the 3rd stoplight (Coborns Superstore will be on your right and Burger King to your left), take a right. You'll go straight (after a 4-way stop), up a hill, etc. You'll pass the old high school on your left and hit a dirt road. Take a left and go down another dirt road.

### Sartell:

Take Highway 10 to Clear Lake. Take a left. Go through Clearwater and take a right on Highway 94. Take the 3rd Exit into St. Cloud (Highway 15 exit). You'll go through approximately 6 stoplights. At the 7th stop light, take a left (you'll see a McDonald's and an Auto Repair on your left). You'll drive a few miles until you see 12th Street North. Take a left. Field is on your left--called Champion Field.

### Becker:

Take Highway 10 to Becker. When you see the grocery store, take a right. Look for the Blue Netting on the fence.

### Elk River:

Take Highway 10 to Elk River. Get to the Proctor/County Rd 1 stoplight. Go left (north) on Proctor.

### St. Augusta:

Take Highway 10 West (towards St. Cloud). Once you go past Becker Furniture World, take a left on County Road 8 (it leads you to Clearwater). At the stop light, take a left, which brings you into Clearwater. At the 2nd stoplight, take a right on to I94. You will travel about 5 miles. Take EXIT 173 onto Opportunity Drive. Take a left and then a sharp right. You will travel into St. Augusta. Take a left on County Road 115. The field will be on the right side.

### Zimmerman:

Take County Road 4 into Zimmerman. Take a right on Main Street (there should be a Flashing Light there). Go approx. 2/3 mile. Take a Right on 2nd St. SE. Take immediate Right up hill. Go past Civic building and field is to the left.
